**RE: ICC Notice of Intention: LJ et al -v- WFE & OICU-IOSCO**

I am giving you the benefit of the doubt and assuming your questions are sincere. If they are not sincere; please be aware that NSA and KGB authorities have the capability of reading every single thought in your mind [Dr John Hall: Govt Mind reading technologies<sup>4</sup>]. The proposed definition for ‘crimes of aggression acts of war’ is:

“Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international – alleged ‘scarcity combatant’ law; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the ‘crime of aggression act of war’.”

**Sustainability Definition:** A Sustainable society practices Sustainable Procreation and Sustainable Natural Resource Utilization Behaviour; i.e. all of its citizens consume and procreate below carrying capacity. Sustainable Natural Resource Utilization Behaviour involves the utilization of renewable natural resources—water, cropland, pastureland, forests, and wildlife—exclusively, which can be depleted only at levels less than or equal to the levels at which they are replenished by Nature. The utilization of non-renewable natural resources (NNR's)—fossil fuels, metals, and minerals—at any level, is not sustainable [Chris Clugston: Scarcity: Humanity's Final Chapter<sup>6</sup>].

**Carrying Capacity Sustainability: I=PAT Equation:** For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarised by what is known as the Ehrlich or IPAT equation, I=PAT. I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

All debt based economic growth fiat currency banks, particularly central advocate on behalf of population and economic growth; i.e. on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits.

In any ecosystem that has not breached carrying capacity limits, “advocating on behalf of economic growth” is advocating on behalf of the consumption and production of finite non-renewable resources.

In any ecosystem that has [breached carrying capacity limits](#)<sup>7</sup>; “advocating on behalf of economic/population growth” is advocating on behalf of the consumption or production of renewable resources that transgress ecological carrying capacity limits. According to some estimates, humanity is [between 700% and 400,000% in overshoot](#)<sup>8</sup>.

*It is becoming evident that the financial and investment community begins to accept the reality of Peak Oil, which ends the first half of the age of oil. They accept that banks created capital during this epoch by lending more than they had on deposit, being confident that tomorrow's expansion, fuelled by cheap oil-based energy, was adequate collateral for today's debt. The decline of oil, the principal driver of economic growth, undermines the validity of that collateral which in turn erodes the valuation of most entities quoted on Stock Exchanges. The investment community however faces a dilemma. It desires to protect its own fortunes and those of its privileged clients while at the same time is reluctant to take action that might itself trigger the meltdown. It is a closely knit community so that it is hard for one to move without the others becoming aware of his actions.*

*The scene is set for the Second Great Depression, but the conservatism and outdated mindset of institutional investors, together with the momentum of the massive flows of institutional money they are required to place, may help to diminish the sense of panic that a vision of reality might impose. On the other hand, the very momentum of the flow may cause a greater deluge when the foundations of the dam finally crumble. It is a situation without precedent.*

Commentator Robert Wise explains the connection between energy and money as follows:

*It's not physics, but it's true: money equals energy. Real, liquid wealth represents usable energy. It can be exchanged for fuel, for work, or for something built by the work of humans or fuel-powered machines. Real cost reflects the energy cost of doing something; real value reflects the energy expended to build something.*

*Nearly all the work done in the world economy -- all the manufacturing, construction, and transportation -- is done with energy derived from fuel. The actual work done by human muscle power is miniscule by comparison. And, the lion's share of that fuel comes from oil and natural gas, the primary sources of the world's wealth.*

World Federation of Exchanges (WFE) and International Org of Securities Commissions (OICU-IOSCO) and all their Members organisations Boards of Directors and Management respondents are hereby charged with 'crimes of aggression acts of war'.



Once Nation State Attorney Generals, ICC Prosecutor and ICC Judges have approved EoP PoW applicants Private Prosecution and Ecology of Peace Decalogue Commandment 'crimes of aggression acts of war' definition; respondents have 25 days (which may be reasonably extended upon written request), to (a) notify the court of their unconditional Ecology of Peace co-operation apology for their former participation in Acts of War 'crimes of aggression'; or (b) file an objection brief, stating in writing their arguments and evidence; to the allegations. ### **EXCERPT OF CURRENT DRAFT:**

#### **Consenting Reasonable Crimes of Aggression Acts of War Respondents:**

All Respondents accused of 'crimes of aggression acts of war' have 25 days, from receipt hereof, to consent to Private Prosecution proceedings; whereby respondents notify applicants in writing that they are capable of, and willingly hold themselves accountable to engage in an honourable commitment to engage in a 'truth, and nothing but the truth' truth seeking legal enquiry to resolve the EoP –v– WiP issues in dispute; without being coercively forced to do so, by prosecutorial, judicial or military authorities.

#### **Non-Consenting Unreasonable Crimes of Aggression Acts of War Respondents:**

All Respondents accused of 'crimes of aggression acts of war' who did not consent to committing to resolve these Private Prosecution proceedings; within 25 days of receipt hereof; thereby legally represent their demand that Nation State Attorney Generals, Supreme Court Judges and Global Footprint Network Standards Committee, et al; officially authorize this private prosecution and its Ecology of Peace 'crimes of aggression acts of war' definition and supporting IPAT evidence.

*Nation State Attorney Generals and Supreme Court Judges and Global Campaign for Ratification and Implementation of Kampala Amendments on the Crime of Aggression* have 25 days, from receipt hereof; to object to this Private Prosecution or its Ecology of Peace Decalogue Commandment 'crimes of aggression acts of war' definition. In absence of any objection; the Ecology of Peace Decalogue Commandment 'crimes of aggression acts of war' definition and Applicants Ecology of Peace Private Prosecution is considered approved by all Nation States and the ICC Prosecutor.

If so: *Global Footprint Network Standards Committee* and any nations *Ecology, Footprint, Population, Natural Resource, Wild Law etc Academic Experts or their critics* interested in the issue have 25 days thereafter; to object to this Private Prosecution or its Ecology of Peace Decalogue Commandment 'crimes of aggression acts of war' definition; or submit factual correction edits to the Applicant's IPAT: Consumption x Population Footprint equation carrying capacity limits statistics. In absence of any objections or corrections; or once objections or corrections are resolved; the Ecology of Peace Decalogue Commandment 'crimes of aggression acts of war' definition and finalized IPAT: Consumption x Population Footprint equation carrying capacity limits statistics are considered approved by the *Global Footprint Network Standards Committee* and any nations *Ecology, Footprint, Population, Natural Resource, Wild Law etc Academic Experts or their critics*.

If so: **ICC, SCSL, ICTY, ICJ Prosecutor and Judges** have 25 days, to object to this Private Prosecution or its Ecology of Peace Decalogue Commandment ‘crimes of aggression acts of war’ definition and IPAT: Consumption x Population Footprint equation carrying capacity limits statistics. In absence of any objection; the Ecology of Peace Decalogue Commandment ‘crimes of aggression acts of war’ definition and IPAT: Consumption x Population Footprint equation carrying capacity limits statistics are considered approved to proceed by all Nation State Attorney Generals, ICC Prosecutor and ICC Judges.

If so: **Obstructing resolution of EoP –v– WiP judicial proceedings** respondents are hereby charged with ‘crimes of aggression acts of war: obstructing the resolution of EoP –v– WiP judicial proceedings’; and have 25 days (which may be reasonably extended upon written request), to (a) plead guilty and apologize; or (b) object to the private prosecution, Ecology of Peace Decalogue Commandment ‘crimes of aggression acts of war’ definition; or plead innocent by filing an objection brief, stating in writing their arguments and evidence. In the absence of respondents (i) pleading guilty and apologizing by providing the court with evidence of their unconditional Ecology of Peace co-operation to implement an Ecology of Peace international law social contract, as required of them; or (ii) filing an innocence plea or objection brief; the respondent/s shall be considered guilty of ‘crimes of aggression acts of war’ [(a)(b)(i) & (ii) collectively herein after referred to as “Plead Guilty & Apologize or Object; failing which they shall be convicted of ‘crimes of Aggression Acts of War”].

If so: **Nobel Respondents** are hereby charged with ‘crimes of aggression acts of war’; and have 25 days (which may be reasonably extended upon written request), to “Plead Guilty & Apologize or Object; failing which they shall be convicted of ‘crimes of Aggression Acts of War”.

If so: **All remaining Respondents** are hereby charged with ‘crimes of aggression acts of war’; and have 25 days (which may be reasonably extended upon written request), to “Plead Guilty & Apologize or Object; failing which they shall be convicted of ‘crimes of Aggression Acts of War”.

**Crimes of Aggression Acts of War Sentencing:** Military and Intelligence agency officials shall deliver the humane and orderly ‘genepool cleansing’ termination by assassination sentencing of all convicted accused; whose scarcity combatant bodies shall not be buried, but dumped into former coal, granary or other related silo’s to be organically converted into compost.

**Bank of International Settlements; Inter-American Development Bank; APRACA: Asia-Pacific Rural & Agriculture Credit Association:**

Bank of International Settlements; Inter-American Development Bank; APRACA: Asia-Pacific Rural & Agriculture Credit Association and all their Members organisations Boards of Directors and Management respondents are hereby charged with ‘crimes of aggression acts of war’.

Once Nation State Attorney Generals, ICC Prosecutor and ICC Judges have approved EoP PoW applicants Private Prosecution and Ecology of Peace Decalogue Commandment ‘crimes of aggression acts of war’ definition; respondents have 25 days (which may be reasonably extended upon written request), to “Plead Guilty & Apologize or Object; failing which they shall be convicted and sentenced for ‘crimes of Aggression Acts of War”.

Unconditional Ecology of Peace co-operation apology for their former participation in ‘crimes of aggression acts of war’ requires respondents to notify the court of their declaration of EoP co-operator status: (a) their individual Unconditional or Conditional EoP social contract Co-operator Oath; (b) Organizational Unconditional or Conditional EoP social contract Co-operator Oath i.e. to immediately beginning proceedings for the termination and closure of, or amendment of their [War is Peace fiat currency debt based economic growth fractional reserve](#)

[banking](#) social contract; the final detailed report of such termination of, or amendment of banking social contract to be completed and provided to the applicants and ICC by 22 April 2015. Such report must clearly, explicitly and with extreme – i.e. extermination from the planetary genepool by humane assassination – consequences for [Taker scarcity combatant](#) violators; require all banking to be based on Ecology of Peace social contract resource limits, by (i) returning to gold or resource mix based currency standard; where all lending / borrowing is to be limited to consumption and production of non-renewable and renewable natural resources below Ecological Carrying Capacity limits; (ii) Employees Procreation and Consumption footprints: all employees must be required to procreate and consume below carrying capacity limits.
